## COLLECTION NOTICE

The provision of DOB allows the school to check the department's NTBE (Not to be Employed) database. The Diocese of Wagga Wagga is also obliged to notify your WWCC status to the NSW Department of Education and the school(s) in which you have been appointed to teach SRE. Any other disclosure of your personal information to a third party will not occur without your permission.

## Basic Accreditation and Ongoing Training

As a provider of SRE in Public Schools, the Diocese of Wagga Wagga signs an annual agreement with the NSW DoE. In order to comply with this agreement, the Diocese is required to provide Basic Accreditation training for SRE personnel and ongoing training in the areas of classroom management and child protection issues.

The five Basic Accreditation modules can be downloaded from the Diocesan website and are to be completed within six months of authorisation, with the requirement that one module be submitted per month. Should a volunteer require an extension for a module they need to contact the Diocesan Catechist Coordinator prior to the due date. Each module should take approximately 1-1 ½ hours to complete.

Mandatory child protection training is currently held every two years- even years, e.g. 2022, 2024.

Volunteers are currently required to update in classroom management every two years. Training sessions are held in each deanery every two years – odd years, e.g. 2023, 2025.

## AUTHORISED CURRICULUM

As part of our agreement with the NSW DoE SRE volunteers must teach an authorised age-appropriate curriculum. The Bishop of the Diocese is responsible for authorising the curriculum. As a provider of SRE the Diocese is required to provide the public with online access to the authorised curriculum via a website. The authorised curricula for the Diocese of Wagga Wagga can be found: <https://wagga.catholic.org.au/sre-catechesis/> The Parish Priest/Administrator chooses which authorised curriculum they would like used in their parish. SRE volunteers need to teach the authorised curriculum chosen by their Parish Priest/Administrator.

## CHILD PROTECTION AND CODE OF CONDUCT INTRODUCTORY TRAINING

## GENERAL CONDITIONS

In volunteering in the ministry of SRE I agree to teach in accordance with the principles and values of the Catholic Church, Diocese of Wagga Wagga. I undertake to exercise due care for the safety and behaviour of students when on school property for the purpose of SRE. I note that no remuneration is to be paid to me as a volunteer SRE Teacher. I also note that out-of-pocket expenses may be reimbursed by prior arrangement with my authorising agent. I agree to cooperate with Diocesan and school authorities.

### **Please read the following and tick:**

- I understand that I must teach the approved authorised curriculum.
- I understand that I am required to complete mandatory Basic Accreditation training (***new SRE volunteers***) and mandatory ongoing training in the areas of classroom management and child protection issues (***all SRE volunteers***). I understand the current minimum requirements may change and that I will be notified should this occur.
- I have completed the Child Protection and Code of Conduct Introductory training and have attached it to this Teacher Engagement Form (***new SRE volunteers only***)
- I commit myself to completing the remaining modules of mandatory Basic Accreditation training within six months of authorisation, and agree to submit one module per month. Should I require an extension for a module I will contact the Diocesan Catechist Coordinator prior to the due date. (***new SRE volunteers only***)
- I commit myself to prepare my lessons diligently, to be punctual to class, and to observe protocol in relation to working with students.
- I understand that should I fail to meet my commitments as a SRE volunteer I could be asked to withdraw from the ministry of SRE in Public Schools.
- I understand that I am free to withdraw from SRE any time by notifying my Parish Priest/Parish Administrator and the Diocesan Catechist Coordinator.
- I understand that I am required to wear the lanyard containing my name tag and Authorisation Card when I am on school property for the purpose of SRE. I also understand that I am to carry photo ID (e.g. driver's licence) and be prepared to present it upon the request of the school.
- I understand that should I become inactive in SRE I am to return my authorisation lanyard and curriculum materials promptly to the Parish.

### **Under 18s**

- I understand that I am able to apply for a WWC number 3 months prior to my 18<sup>th</sup> birthday. I understand that I need to apply for a WWC number and provide a copy of the clearance letter to the Diocesan Catechist Coordinator **BEFORE** my 18<sup>th</sup> birthday in order to keep my authorisation.
