# **Basic Accreditation and Ongoing Training**

As a provider of SRE in Public Schools, the Diocese of Wagga Wagga signs an annual agreement with the NSW DoE. In order to comply with this agreement, the Diocese is required to provide Basic Accreditation training for SRE personnel and ongoing training in the areas of classroom management and child protection issues.

The five Basic Accreditation modules can be downloaded from the Diocesan website and are to be completed within six months of authorisation, with the requirement that one module be submitted per month. Should a volunteer require an extension for a module they need to contact the Diocesan Catechist Coordinator prior to the due date. Each module should take approximately 1-1 ½ hours to complete.

Mandatory child protection training is currently held every two years- even years, e.g. 2022, 2024.

Volunteers are currently required to update in classroom management every two years. Training sessions are held in each deanery every two years – odd years, e.g. 2023, 2025.
